The system includes government instructions, detailed instant edit checks, year-to-year data transfer, data import capabilities, and conversions from other systems. Licensees are entitled to expert support on systems and forms issues at no additional cost. In the early 1980s, Pension Reporter was the first PC-based software introduced for producing 5500-series forms and schedules.
